Enrichment Program Monthly Pass Contract

Overview

Frontier Academy offers a *Monthly Pass* for the Enrichment Program. Families are able to sign up for Before School Care, After School Care, and Friday care, or a combination of the different branches of the program. We offer full time and part time attendance options. Full time attendance is considered 3 or more days a week and 3 or more Fridays per month while Part Time is 2 or less days per week for the Before and After School program and 2 or less Fridays. Children must be registered and enrolled in the program and must commit to the pass on a monthly basis. Families may enroll in the monthly pass at any time. A 14 day notice is appreciated if the program is no longer needed, otherwise families agree to a month-to-month plan through the remainder of the school year.

The cost of the monthly pass is dependent upon the branches you wish to enroll your child in. You may choose one, two, or all branches of the program. The monthly pass fee will be debited the month of service; August's services will be debited on August 25th. If the 25th of the month falls on a holiday or a weekend, the payment will be drafted on the next business day. All fees are subject to change with a 30 day courtesy notification.
